[i] Invited everyone to the Corporation's Divali Function to be held on Friday November 02, 2007 from 7:00 p.m. at the Office Compound.

[ii] The government's promise of water for all was only for the two weeks before election. Under the United National Congress [U.N.C.] government 80% of the people were receiving water but under P.N.M. 80% are not getting any.

[iii] Flooding is a serious issue in the entire Penal/Debe Region. The farmers especially are feeling the loss of thousands of dollars every year but this government is doing nothing to assist these people and they are claiming to be spending millions of dollars to have water courses cleared.

[i] Thanked all those who assisted him during his absence especially in chairing the Public Health and Gender Committee Meetings.

- [ii] Requested the backhoe for two days at the Ravi Bharati Temple Grounds.
- [iii] Requested the letters from Town & Country Planning Division and also from the Director of Surveys with respect to the Ramally issue.

888. **Councillor Diptee Ramnath made the undermentioned comments/requests:-**

- [i] The Ravi Bharati Temple Yagna would start soon and the backhoe and a gang were already approved. Assistance could be given from his district's allocation.
- [ii] Wished all the candidates the Best in the upcoming general election on November 05, 2007. Everyone has the opportunity to put the best candidate to represent them.
- [iii] The Councillors are the representatives of the people and have to find means and ways to bring satisfaction and result. They should start by re-visiting the scavenging systems in place for Penal Central and Debe Central and look to improve this.
- [iv] Wooden bridges in the region and, especially his district, are in a terrible state with some already collapsed. The Corporation, especially at this election time, should do everything necessary to highlight these issues and get into the bridges program at the Ministry level.
- [v] Many places, flood very easily, such as Katwaroo Trace, Clarke Road Junction, Penal Rock Road entrance, Charlo Village, Clarke Road, Sumanie Trace, among many others. The Council needed to pool its resources in an effort to alleviate this problem one at a time.

889. **Councillor Premchand Sookoo made the undermentioned comments/requests:-**

- [i] When Council made requests to clean the drains along the main roads they were told that this cannot happen because there is no authority to do this. Now, whenever it floods, the Corporation gets the blame.
- [ii] At a meeting he requested as a matter of urgency, three bulbs to be changed in Tulsa Trace for a Yagna, however, this was not done and he wanted an explanation.
- [iii] It is a sad day when a government that says it is caring cannot pay water checkers who worked week-ends since April, 2007. The people are desperate for their money and cannot get it. People have to wait at the hospitals from 4:00 a.m. for medication and some patients resort to sleep on the floors. To get a new passport is a disaster.
- [iv] It was agreed that at least one box drain would be completed every month, however, to date there was no signs of this and wondered if the Council was being victimized by Administration.
- [v] Contracts were awarded to cutlass cemeteries, and work had already started but not one Councillor was aware of this because no documents came to Council.
- [vi] R.D.C., PSAEL, PURE, are some of the new companies established by this government but no one can say what their responsibilities were and what works they have done for Penal/Debe.
- [vii] Extended to the Hindu Community Divali Greetings. Also to the voting public he wished that their conscience be their guide.

- [ix] Requested the police to investigate the corn and watermelon vendors located at the entrance to the Penal Presbyterian School.

- [i] Was having problems since 2003 to have his allocation utilised into recreational facilities in his district. He is very disappointed that none of his requests are fulfilled.
He commented that recently he and Councillor Premnath Boodoosingh were lucky to get two pavilions built by N.G.C. however, whatever additional works were needed was completed for Councillor Premnath Boodoosingh and nothing was done for him.

The Sports Club in his area refused to accept the pavilion and the Village Council had to accept the keys. He hoped that this discrimination stopped and the facilities [especially electricity] are supplied.
- [ii] It was very unjust that the people who live on Caroni lands have to travel to Port-of-Spain in order to pay land tax. The people in Port-of-Spain are already complaining about crime & traffic among other problems and this government is just adding to the problems by telling these people to go to Port-of-Spain to pay land tax.
- [iii] TrinityPavers Ltd. did work and damaged the roads and private premises and left the place unrestored. There is now a new contractor and arrangements are made to have a meeting with them in order to have the problems resolved.

- [iv] Was having problems with A.P.I. with respect to paving of a roadway but N.G.C. said they would do the work.

- [i] At the last Youth, & Citizen Liaison Committee Meeting he made mention of a primary/secondary schools music festivals. He requested some O.J.T.'s to assist in this project.

- [iii] As Chairman of Communication he had been trying to get a complaints system going which includes a list of complaints, the nature of the complaints, and who are they referred to and what remedial measures taken, as a whole system where these information could be easily generated into hard copy.
- [iv] Questioned the function of the Corporation security when the station is located next to the abattoir and everything in the abattoir are stolen. Also for months he has been complaining about a blocked drain in Palmiste and nothing was done by the security.
- [v] Vehicle #TAT-9440 was making a "dump heap" next to Hillpiece Recreation Ground and wanted the security to addressed this matter.
- [vi] As much as he requested a list of contractors which he hasn't received yet, he understands that the same contractors were working again.
- [vii] The handing over ceremony for Hillpiece recreation ground pavilion was scheduled for September 29, 2007 and requested the provision of water and electricity, the area be cut and cleared for the occasion. He was proud that every recreation ground in this district has a pavilion.
- [viii] Natural oil and gas was flowing from the ground into someone's garden located next to the Hillpiece recreation ground.

OTHER PUBLIC BUSINESS

785. Councillor Premnath Boodoosingh made the undermentioned comments/requests:-

[i] Mr. Bharat Deonath of 72 Hillpiece Road was diagnosed and hospitalized with leptospirosis. On several occasions he raised the issue of rats and mosquitoes infestation in the Palmiste district and especially in the Palmiste Park. The person's situation had deteriorated to the extent that he now suffers from a heart condition. He requested a meeting with the County Medical Officer of Health department, the Public Health Inspector department and the Palmiste Park Committee to resolve this matter.

Also a letter be written to the Minister of Health regarding Mr Deonath's medical situation and also a letter be written to the County Medical Officer of Health and copies of both letters be given to the gentleman.

He stated that he saw no progress in terms of baiting or spraying and although there are always excuses for not getting the job done, he knows that funds are available to hire the manpower.

[ii] He went to San Fernando City Corporation with respect to a building plan, and had the opportunity to look at that system of operation. This Corporation could implement some of their procedures especially that of having the signature of the Chairman of the various Committees on documents that are sent to meetings for approval.

[iii] There is gossip that the Chairman of the Finance Committee selects persons for contract. He made it abundantly clear that he has never been involved in the tendering process or the tenders section.

[iv] As Chairman of Communication Committee he was not told that Tamara Silochan was leaving and did not see any document at any meeting for her replacement and he understood someone was already working in the section. Tamara was a very good worker and complimented her on her new job. He commented that all employees should become computer literate.

[v] He noticed that workers under short term employment were paid different rates for the same position they were hired into.

[vi] Mr. Hakim Ramjohn built a garage over a public drain blocking the public access. Although he talks about this at every statutory meeting but nothing is done about it and nothing may be done until there is a death or serious accident.

[vii] There was a system in place where Insect Vector Control Division and the Corporation worked collaboratively but this had since been stopped and no one could answer for spraying for mosquitoes or rat baiting.

[viii] A document was awarded for Union Hall recreation ground and no information was forthcoming as yet, nor did he get documentation with regards to work being carried out at the new building.

[x] Complimented Jaime Harrinarine on work done at the Corporation and congratulated her on her new job.

[ix] Complimented the workers who spent weeks under a tent and strived to get a new building.

[iix] Hoped to get a status report from the Accounts Section and also from the Personnel & Industrial Relations Officer Section.

786 **Councillor Willvan Ramlakhan made the undermentioned comments/requests:-**

[i] The recent showers in Penal resulted in serious flooding in the vicinity between Changoo;s Hardware & Oliverie Drive where children from a number of schools have to traverse. He addressed this issue at most meetings but no result to date.

He suggested the Corporation cut across the road from Oliverie Drive redirecting the water into the main drain. Urgent action needed to be done especially since many schools are located in the area

[ii] Mosquito and rat infestation is terrible throughout the region and there is need to seriously look at this situation before it gets even worse.

[iii] As Chairman of Personnel he would like more communication with the P.I.R.O. Section. However he visits the office regularly and goes into that section for updates but hardly are his enquires answered.

[iv] Complimented the Public Health Inspector III & Road Officer II especially for work done the Penal Presbyterian Church compound and, with the little resources available to them, they were trying their utmost to bring relief to the people.

[v] There is no replacement yet for the Workshop Foreman and again recommended Mr. Chandath Popo.

787 **Councillor Roy Kssoon made the undermentioned comments/requests:-**

[i] Requested his balance on recreation grounds be utilized to electrify Woodland recreation ground.

[ii] The situation at Jacksingh Street remained the same. Trinity Pavers Ltd. damaged people's property and left the place unrestored. Another contractor is doing work now and he could not say who they are.

[iii] The Estate Management and Business Development Company Ltd. [E.M.B.D.C.] relocated residents but has not put any of the basic necessities for the people.

[iv] Requested a gang to clear the drains in his area because it is very difficult for the backhoe to work.

788 **.Councillor Rampersad Hardial made the undermentioned comments/requests:-**

[i] Congratulated Jaimee & Tamara on a job well done and wished them well.

[ii] Flooding is very prevalent in Penal/Deb and so far this year there has been no serious occurrence, however, if there is persistent showers then serious flooding will occur, and, it is a total waste of funds hiring backhoe to clear water courses in the rainy season.

[iii] Under this P.N.M. Government there is no development - the roads and traces are terrible with only a very few repaired, the government boasts of billion dollar budget but Penal/Debe receives barely any.

[iv] The Corporation was boasting that the murder rate had dropped, however, he refused to talk about the rise in the other criminal activities.

[v] In his area the people are dependent on the rainy season to get a regular supply of water. There are always problems with pipe borne water supply and also with T. & T.E.C. and TSTT where the service is poor and irregular.

[vi] A contract was awarded for work in the Petrotrin Barrackpore recreation ground but hardly any work was done.

[i] With respect to the rat invasion in the Palmiste area, he always said the only way to alleviate the problem was to close the vending area for a period of time in order to bait the area.

[ii] Flooding continues to be a serious problem in this region and he supported all efforts to alleviate this.

[iii] Wooden bridges in his district especially, are in a terrible state with the Hope Trace & Kangaroo Trace bridge already collapsed. Everything possible needed to be done in order to assist those residents.

[iv] The Council needed to ensure its contribution in the roll-out programme on Local Government Reform. The Minister of Local Government has to be made aware of the needs of the Corporation and those community meetings are a means of letting the people know what is happening with the Corporation.

[v] Required 11 cylinders for a water project in Teeluck Trace.

[vi] Wished Jaime & Tamara well on their new jobs.

780. **Councillor Carl Dabideen made the undermentioned comments/requests:-**

[i] Reiterated the uselessness of Committee Meetings when Councillors resort to bring their issue to Statutory Meeting. Week after week and month after month they complain about lack of control, yet they continue to approve documents.

[ii] Administration continues to usurp Council's authority and we continue to allow this. Committees are non-functional and everyone was complaining, yet they do nothing to rectify the situation.

[iii] Councillors were not dealing with the bigger issues at Statutory Meetings but raising matters that should be dealt at Committee stage.

[iv] As we observe independence it is sad there is nothing to celebrate. We were thrown out by our colonizers and we did not fight for independence as India did. We are now working towards Vision 20/20. Local Government is now dysfunctional with respect to this vision for example, we are spending millions of dollars to combat the surge of crime yet we are not paying attention to the root cause. We should be focusing on reducing pre-term babies and putting an education system in place that pays attention to life skills from pre-school straight up to secondary schools.

Rather than having objectives like these to combat crime we are just providing a plaster by building houses instead of building communities.

781. **Councillor Premchand Sookoo made the undermentioned comments/requests:-**

- [i] Everyone made a contribution about the rat infestation at the Palmiste vendors booths. Those booths were built under the U.N.C. administration however, when the P.N.M. took over they distributed the booths to friends of the party.
- [ii] With the floods of last year the Prime Minister made visits and identified areas to assist and Penal/Debe was told to submit their estimates. However, up to present day Penal/Debe did not get the amount requested nor the attention of the various agencies.
- [iii]The Minister of Local Government also visited during that flood and also made promises, but after so long nothing was done.
- [iv] So too, the former Minister of Agriculture made visits and made promises, and up to date not one road nor bridge was repaired in Penal/Debe and he said he spent 40 million dollars.
- [v] The Corporation received the same treatment with respect to water trucking where promises were made for additional funding, however, up to date contract workers have not been paid.
- [vi]The Local Government Reform roll-out programme is an exercise in futility since the Minister is fully aware of the problems that exist in Penal/Debe.

782 **Mr. Ramdeo Rambalack – St. Patrick East CACC**

Mr. Rambalack who has 17 years experience in rice production addressed Council and submitted two documents on the increase in rice production in order to resolve the rice industry.

783 **CHAIRMAN’S CLOSING REMARKS:-**

The Chairman stated that this may be the last Statutory Meeting in this building. He also reminded members of the implementation meeting beginning in September.
