682. The meeting commenced at 9.20a.m and prayer was led by Councillor Roy Kissoon.

683. **CHAIRMAN'S OPENING REMARKS:-**

The Chairman welcomed all to the Twelfth [12th] Statutory Meeting. Dr. Sammy stated that in keeping with the amendment to Act 21 of 1990 there would be a continuation of Council effective 13th July, 2007 and meetings would be continued. He hoped that all releases of allocations would be fully utilized in this financial year.

He advised the meeting that he had a three way conversation with Ms. Jokhan and Mrs. Kamla Persad Bessissar and Mrs. Jokhan agreed to hold her hand on suspension or termination of the Sixteen [16] OJT'S in the main office, pending a visit by her investigating officers. In spite of the request of both the Chairman and the CEO, for reassignment all sixteen [16] were sent home.

[ii] The Chief Executive Officer informed that he had spoken to Mrs. Jokhan and she had agreed to re-assign the Trainees and an Officer from the O.J.T. Office was sent to investigate the matter.

725. [i] Alderman Dr. Allen Sammy stated that the Permanent Secretary was playing games with this Council with respect to addressing the problems of accommodation. He added that he had asked that the M.P. for Siparia Ms. Kamla Persad Bissessar to address this at Parliament.

[ii] Councillor Premchand Sookoo enquired as to the cost attached for an advance payment for six [6] months rent for the proposed building.

[iii] The Chief Executive Officer informed that the cost would be six hundred thousand [\$600,000.00] for six [6] months and that the County Superintendent had the details for additional work for the proposed building.

[iv] The County Superintendent Mr. Heru informed that there was an estimate in the sum of one million, one hundred thousand dollars [\$1,100,000.000] for upgrading and rental of proposed building.

- [v] The Chief Executive Officer stated that the proprietor was responsible for upgrading the toilets and installing the air condition units and ceiling.
- [vi] Councillor Carl Dabideen stated that three [3] weeks had passed and nothing was being done to resolve the problem of accommodation. He pleaded with his colleagues not to back down so that the Ministry of Local Government would be pressured into resolving the matter. Councillor Dabideen indicated that the OJT Trainees were sacrificed by the mischievous acts of the monthly paid officers and questioned their motives.
- [vii] Councillor Premnath Boodoosingh stated that the workers have the right to struggle for their needs and as a responsible Council we should ensure that there is a safe working environment for all workers. He enquired whether a financial statement along with the proposed plan was submitted to the Minister of Local Government. Councillor Boodoosingh indicated that as the Chairman of Finance Committee he had no information with regards to expenditure and commitments.
- [viii] The Chief Executive Officer informed that no statements were completed for June and July because of the situation arising out of the Trainees and efforts were being made to update the Financial records.
- [ix] Councillor Diptee Ramnath stated that we should seek legal advice and send letters to the Minister of Local Government. Councillor Ramnath also added that the Council seek a meeting with the Minister of Local Government and the Minister of Labour in an effort to resolve the protest action.
- [x] Councillor Premnath Boodoosingh informed that he attended two [2] meetings where the Minister of Local Government gave a ruling that the Penal/Debe Regional Corporation use their allocations and supplemental funding would be given.
- [xi] Councillor Diptee Ramnath stated that the PDRC should have that approval in writing prior to making any decisions.
