1601. The Meeting commenced at 9:45 a.m. with a prayer led by Councillor Roland Hall.

CHAIRMAN'S OPENING REMARKS:-

1602. Alderman, Dr. Allen Sammy welcomed all to the meeting.

Following - on my opening remarks made at the November Statutory Meeting on the impending cut to PDRC's budgetary allocation for 2008/2009, our worst fears have been realized. An official instruction to cut \$ 13.580M is even worse than initially predicted and will severely impact negatively on the Corporation's plans to meet the goods and services needs of its 90,000 inhabitants. More frightening is the fact that the budget cut instruction is based on an oil price of \$55 US per barrel. With prices now hovering in the low forties and Merrill Lynch's prediction that the price could drop to \$ 25 US per barrel in 2009, the prognosis is exceedingly grim.

What is alarming is the priorities of government in respect of important deliverables to the national population. Health care, for example, is certainly more important than a rapid rail system study yet this is retained and hospital construction in Couva and Port of Spain are put on hold. US President Elect Obama has already indicated that he will reduce the dependence on fossil fuels, of which T&T is a major supplier, and promote greater use of solar and wind energy. For example, he has mandated that 100,000 electric cars will be on US roads in 2010 and hundreds of thousands more by 2012. When then, will the government's economy rebound sufficiently to build these hospitals?

People should be reminded that when the UNC demitted office in 2002, inflation was at 4.5%. It is now 15.4 % because the cost of doing government business has never been controlled since that time and inflation rose with wanton expenditure. There is no signal that expenditure on mega projects will be reduced. Between 1983 and 1993, Trinidad and Tobago experienced negative growth and it was not until 2002 that per capita growth returned to the 1982 level. The recovery period took twenty years. Earlier this month, the Minister of Finance said that the country is not in a recession. We do not know if this is in fact so since it takes a minimum of one year measuring per capita GDP in real terms, from quarter to quarter, before the true economic pictures emerges.

Our vulnerable and fragile off shore economy which employs only five percent (5%) of the workforce generates ninety percent (90%) of our foreign exchange but this is exacerbated by the fact that we do not determine prices for oil and gas, but rather are price takers rather than price makers. Since the off shore economy impacts directly on the on – shore economy, experts are already predicting that in 2009.

construction will decline (negative growth)

The urea, methanol, ammonia and steel plants at Pt. Lisas will lay – off workers (negative growth)

Manufactured products will become more uncompetitive regionally because of inflation and increased cost of production leading to lay offs (negative growth)

Agricultural production in the face of rising production costs will decline (zero growth)

Tourism will decline because of the recession in the USA, Europe and Japan (negative growth)

Remittances from migrants in the diaspora are already shrinking significantly because of the massive loss of jobs abroad

Only the domestic economy is likely to grow, perhaps by two percent (2%) in 2009 only because of the government's current investments in the economy, before it probably stalls in 2010

Some impacts on the Penal Debe region for 2008/2009.

1. Garbage collection will have to be reduced from four to two days per week leading to the likely increase in vermin, including the rat population and the increased possibility of leptospirosis and related diseases.
2. Water trucking will have to be halved leading to an agitated population and the real possibility of social unrest.
3. The maintenance of play grounds will be minimized creating further restlessness among the youth who are already agitating for better facilities and night time sport. The government has already announced that perimeter lighting of grounds has been cut.
4. The proper upgrade of the markets at Penal and Barrackpore will have to be put on hold while vendors will continue to vend in unsanitary conditions at the roadside thus increasing the probability of dust borne diseases, pedestrian and traffic congestion and public disgust.
5. The considerably reduced ability to address the annual flooding problems through the construction of box drains and the maintenance of water courses.
6. A severe cut back on the on going spraying programmes for mosquito eradication and rat baiting, leading to a rise in cases of dengue and leptospirosis
7. The inability of the Corporation to pay its bills for street lights and the consequent creation of dark spots as bulbs are blown. Increased criminal activity is anticipated as these elements move under the cover of darkness.
8. Poor maintenance of Roads and Bridges and water Courses – Availability of Material decrease.

I am predicting that there will be a further general breakdown in law and order in the Penal Debe Region and increased social agitation as the ability to deliver goods and services to our citizens shrink with a collapsing economy. This year in office will be truly challenging.

Statutory Meeting

- [i] The Chairman Dr. Allen Sammy read from a document and quoted “I wish to bring to Council’s attention the pronouncement by the Honourable Prime Minister last week Thursday that the national budget is to be cut by \$ 6 Billion. Earlier last week, the Budgets Division had indicated unofficially to the Corporation that a budget cut to us is impending. I have since been informed that this cut is likely to be 40 %. The PDRC’s 2008/2009 allocation for development work is \$ 7, 650 Million (\$ 1.5 M additional for vehicle purchase) and an additional \$10.5 Million for construction of box drains, road patching, etc including the purchase of materials. Of the \$18, 150 Million dollars for the actual physical delivery of services, a budget cut of 40 % is going to reduce the PDRC budget to \$ 10.95 Million. This will lead to severe community fallout since there is a reasonable expectation of infrastructural works on pavilions, drainage, markets, roadways, bridges and recreation grounds. The current allocations are already small and further reduction will have serious negative impacts in a number of areas. For example, only \$ 1.6 M and \$ 2.9 Million have been allocated for drainage and bridges respectively. The PDRC needs at least \$ 4 Million for immediate drainage works to prevent annual flooding and the resulting millions of dollars losses to household items, home damage and crop and livestock destruction. Almost every single one of the fifty eight (58) wooden bridges need annual repairs and when these become impassable, hundreds of motorists are affected daily as they seek alternate routes to work, school, shop and recreate. As we speak, the Laltoo Trace Extension bridge remains closed because of the cost of material. One mora plank, 3” x 12” x 14 feet costs \$ 2, 834.75 and dozens are needed annually.

I am putting the blame squarely on a government that refuses to allocate resources in a rationale and equitable manner to the PDRC, based on the real needs of its citizens. Poor planning is now going to further exacerbate an already bad financial situation within the Corporation and thousands of citizens will suffer further. We are perhaps the most physically under developed of the fourteen municipalities judging from the condition of the water courses, roads, bridges, drains and recreation grounds.

On a happier note, may I extend congratulations to Members of Council for a very successful 6th annual Civic Reception and Awards Ceremony held at the Lall's Shopping Complex on November 22nd 2008. Eighteen (18) SEA students and thirty one (31) Advance Level scholarship winners, all but three living within the region received awards for academic excellence. Eighteen (18) community groups from within the region and thirty one (31) individuals were also recipient of Certificates of Appreciation. Seven retirees were honoured, as well as ten national cricketers (different age groups) and eighth (8) schools for national achievements. The PDRC is extremely proud of its achievers and congratulate the youngsters as well as the groups and individuals who have helped to shape our distinguished cultural, economic and social heritage over the past few decades.

My sincerest congratulations to the hands - on organizers of the event and those who helped namely Sabrina Mowlah Baksh, Leisha Sookram, Neermala Khemraj, Rema Ganga Persad and Mukesh Raghoonath.

The word in political circles is that the Penal Debe region would be absorbed into Siparia next year. This would be a sad blow to our 90,000 citizens who have come to accept rapid responses to their requests. When a region is made too large, the voices of the communities are lost and the true meaning of local government disappears. Efficient and effective local government requires that the people be always within touching distance of their Councillors and the institutional edifice which they can access at a moments notice.

Mr. R. Bickram informed:-

- [a] That schedules are available but due to demands and disruptions it is difficult to follow:-
- [b] That Monkey Town was scheduled to receive water once per week on Mondays.
- [c] That the Regulated Industries Commission was the middle communicator between the customer and W.A.S.A. adding that recommendations were submitted to W.A.S.A. by the Regulated Industries Commission.
- [d] That steps were being taken to rectify the problem at the Clarke Road Well.
- [iii] Councillor Diptee Ramnath requested that a letter be sent to the Utility Department Petrotrin Santa Flora – Re: Abandoned Wells. He said that sources of water included Haggard Trace and abandoned water wells at various sites. Trintopec water well sites should also be identified.

[v] **Councillor Premchand Sookoo stated:-**

- [a] That water lines were laid in Sadoo Village, Digny and to date there is no water, despite the fact that the residents have paid for a water connection.
- [b] That road restoration works is long over due at Tin Pan Alley, Barrackpore since the running of water lines were completed sometime ago.

- Sugar Road
 - Papourie Road

[b] He commended Municipal Police, Accounts Section, Secretariat, and Stores for their support.

[c] Requested that Hillpiece Recreation Ground and Palmiste Play Park be cut.

[d] There is a broken electricity pole on the S.S. Erin Road near Cuchawan Trace which is dangerous. We should contact T.S.T.T. agent responsible urgently.

[e] A meeting should be called with Insect Vector re: spraying for dengue.

[f] Petrotrin is damaging our roadways with its trucks. We should talk to them on a partnership on community projects and sharing of resources.

[vi] **Alderman Roland Hall made the following comments:-**

- Our athletes did well in Beijing Olympics.
- Thousands of graduates from U.W.I. and U.T.T.

Last but not least though my believe is that we are a nation of prayer in celebrating Divali, Spiritual Baptist Day, Christmas, Carnival the mix of Chutney an Soca there is always a Crusade running some were in this Country at any point and time the attendance of the peoples of this Country to the Mandir, Mosque and Churches, under tents, houses and those of us who pray at home during the day continuously. This is what keeps us going Chairman from the above I thing we are spiritually uplifted.

Mr. Chairman I ask of us here today to let us continue praying, try out best to live in Peace and unite and may God bless us all.
